The main goal for 2018 is to continue to provide an impartial forum for hearing cases brought by the City for violations of the Madison General Ordinances. In addition the court will continue to use restorative justice practices and programs to address ordinance violations. In 2018 the court hopes to continue the funding for a homeless court program to cover the costs associated with implementing the goals of the project. The court will also continue to work on juvenile justice initiatives in partnership with various agencies to reduce disproportionate minority impacts. These include the juvenile diversion program that began in September of 2015, and the programs with the school district, Briarpatch and Centro Hispano.

Court Services

SERVICE DESCRIPTION:

This service handles approximately 30,000 cases per year including traffic, parking, first offense drunk driving, disorderly conduct, trespassing, building code violations, juvenile violations, and truancy. The Municipal Court also holds hearings in the Public Safety Building for those persons held in jail and issues warrants for arrest and inspections. If a forfeiture is not paid, the Municipal Court can suspend a driver's license, hunting or fishing license, issue a warrant for arrest, intercept a tax refund or start a collection action.

SERVICE GOALS

What community need does the service address?

Providing a impartial forum for hearing cases filed in the Municipal Court. Attempting to prevent future violations by using restorative justice practices and programs.

Who are the recipients of the service?

Adults and juveniles who have court cases with the Madison Municipal Court.

What outcomes will be produced at the proposed funding level?

Continue to provide a fair and impartial forum for persons charged with violating city ordinances. Continue to provide options for persons to pay through payment plans or community service when needed. Use restorative practices and programs to help address the underlying reasons for the ordinance violations.

What strategies are planned for 2018 to advance the stated outcomes?

Continue to provide commonsense information, both orally and in writing, to persons who have court cases and are not familar with the court system or the legal procedures. Provide easily understandable forms and oral advice to those needing payment plans or community service options. Continue to work on juvenile diversion programs and truancy court in the schools. Continue to work to assist homeless persons with ordinance violations through the homeless court project and the Muncipal Court defense project.
