I graduated from UC Berkeley in 1976, majoring in economics. I attended Harvard Law School a little while later, graduating in 1980. I moved to Madison in 1983 and initially did graduate work in economics. I worked at Foley & Lardner from 1984 to 1989, at which time I took a job at the state Justice Department. I met my wife, Judy Gundersen, around this time. As of May 28th, we will have been married 34 years. Judy and I have had three kids together, all of whom grew up in Hill Farms, attending Van Hise, Hamilton and West. Before moving to Hill Farms, we lived on Merrill Crest Drive, just west of Whitney Way and north of Regent and also in District 11.

At DOJ, I had the opportunity to work on a number of high-profile cases, such as an action to enjoin abortion clinic blockades in Milwaukee in the early 90's, the federal redistricting litigation that same decade, and the school funding case, among others. I often worked closely with then-Attorney General Jim Doyle. Attorney General Doyle and I traveled to the United States Supreme Court in 1996 to argue a case challenging the validity of the 1990 census. I also worked closely on an important Voting Rights Act case with then-AAG Kathleen Falk.

In late 2001, I left DOJ to work at the Division of Hearings and Appeals as an Administrative Law Judge. The principal agencies that I heard cases for were the Department of Employee Trust Funds, Department of Corrections (Probation and Parole), state Claims Board (innocent convict claims), and Tax Appeals Commission. In July 2009, I was appointed to the Dane County Circuit Court by Governor Doyle. I was twice elected without opposition. I served on the juvenile rotation my first four years as a judge and on the civil-family rotation my final seven years. I retired from the court in August 2020.

Outside work, I represented the Van Hise attendance area on a citizen committee set up by MMSD to explore ways to balance economic and ethnic diversity among West area elementary schools. This was in the mid-90's. In the last two years of the second millennium I served as president of the Van Hise PTO. In the first decade of the third millennium I was appointed to the Madison Board of Review and subsequently became chair. I was required to resign this position upon becoming circuit judge. Since my retirement I have done a modest amount of pro bono work as an attorney. If I am not appointed to this seat, I anticipate doing more of this. I would also likely seek appointment to a city or county citizen body. Judy and I have had two grandchildren born in the last two years (one was born this past May 2nd). They live in Glendale, Wisconsin, and provide a source of great happiness for both of us.

I was the assistant coach on one of our kids' youth soccer teams for several years, as well as of a coach-pitch baseball team. I assisted my son David in delivering Cap Times newspapers when he was a carrier (in the mid-2000's). Judy and I are members of Covenant Presbyterian Church at the corner of Segoe and Mineral Point Road, although my attendance is not considered exemplary. We've been members of the Hill Farm Swim Club for almost as long as we've lived in Hill Farms. For two years in the late 90's we were licensed as foster parents by Dane County. When I was twenty, I served in Viet Nam as a non-combat medic. The VA recently determined that I am disabled as a result of this service. I would say there's no chance my disability would prevent me from completing Arvina Martin's term or, with luck, from serving at least two elected terms.

I am applying to serve as Alder for District 11 because I believe in public service and because I'm capable of doing the job reasonably well. I am retired and no longer have kids at home. This gives me more time to devote to the position than someone who is working and/or raising a family. I have rarely had complaints about day-to-day City operations. However, I would be entirely capable at vetting complaints of district residents and passing them along in a constructive manner to the appropriate department for response. In terms of broader issues, such as mass transit, increased local density, traffic enforcement, policing, and homelessness, among others, I'm reasonably representative of the people who live in this district and generally share their interests and values. We have lived within District 11's current boundaries for 32 years. When I was a judge, I biked most days to work. I continue to use a bicycle as my main mode of local transportation, at least in the warmer months. There were times when I worked downtown that I principally took the bus. Like the vast majority of District 11 residents I strongly believe in democratic self government, the rule of law, and the elimination of unnecessary barriers to the exercise of the right to vote. As noted, we raised three kids here and I strongly relate to this neighborhood's new generation of parents in matters of their children's education, issues of traffic safety and otherwise. A significant number of District 11 residents have continued to live here after their children moved out. My wife and I are in this class. You might say I skew a little old, and that's fair, but I'm still ten years and a day younger than the current President.

I'm a good listener. I can read a budget. While I don't think many would describe me as politically correct, I am aware of the substantial diversity that is the hallmark of this country and ultimately of Madison--not simply racial and ethnic diversity, or foreign and native born, but diversity in matters of sexual orientation, gender identity, religious and non-religious belief, and broadly political perspective. I view this underlying diversity as a real strength of our country and of our community.

My sole objective in serving on the Common Council would be to represent all of the residents of District 11 in a conscientious and reasonably competent manner.

At this point in time, I would not anticipate seeking election at the conclusion of the appointed term. However, this may change, particularly if I feel I am capable of making a positive contribution to this essential institution of local self government.

Thank you for considering my application. My expectation is that you will have a sufficient number of quality candidates that the choice you end up making will fully satisfy the residents of District 11, as well as the person whose seat is being filled.

With 10 years of working for the UW System and direct experience leading change management, communications, customer service and training, while being a Board Member for Westmorland Neighborhood Association for almost five years, I can be a great fit for the District 11 Alder position. BIOGRAPHICAL RESUME

I have taken numerous professional development courses through UW-Madison to further advance my project management and change management skillset.

WORK – CHANGE MANAGEMENT: In my current Change Management role at UW System Administration, I interact daily with our communications, customer service, training and web teams. Because of this daily interaction, I have become broadly knowledgeable over these areas of our operation. Over the years in this role, our teams have created and refined a methodology to take any change and formulate a strategy to address, engage, communicate and/or train impacted stakeholders.

NEIGHBORHOOD/CIVIC EXPERIENCE: I have gained and continually grow as a leader through causes I volunteer for: Academic Staff Council Member for UW System Administration, Class Agent for my alma mater (i.e., St. Norbert College), Alumni Director for my former high school soccer team, Instructor for the Couples to Couples League and FOCCUS Mentor for engaged couples within the Madison Diocese.

TOPICS OR ISSUES OF FOCUS


Living in District 11 for the past seven years, there have been topics and issues that need the appropriate level of focus:

Statement on why you wish to serve:

When a "very young man" in 1993, meeting with the City Engineer for an orientation when beginning to fulfill my appointment by Mayor Soglin to The Board of Public Works, Mr. Nelson could see that I was struggling to understand the wide variety of work that body oversees and the complexity of the agenda that covers the numerous facets of his department. However, his summary at the end of our meeting made a huge difference and has guided me ever since. He said that the most important part of the job as a commissioner *"is to respect the citizens and make sure they experience being heard."*

Ever since, that has been my North Star, guiding me in my public service. In fact, the most satisfying aspect of my decade of service on the Common Council was those times when I made a difference for a citizen seeking to be heard, somebody with a complaint, an idea, or a request.

I will work to be an effective voice for the citizens of the 11th District while empowering individuals and neighborhood associations to have their voices heard. My sole intention for seeking this appointment is to serve citizens of the 11th District, listen to their concerns, connect them with their city government and empower them to work effectively with staff and their future elected representatives.

Statement of what you wish to accomplish:

I am ignorant of the politics of our present common council. However, I remember a divide when previously serving as an alder, beginning in the same class as Alder Vermeer. I was raised with strong progressive sensibilities that I proudly continue. Now, I enjoy my former opponents as friends that I admire and respect, with whom I continue to get together for occasional lunches. I hope to be wiser during this brief term and work collaboratively with *all* my colleagues.

Also, I strongly endorse the initiative of the present elected representative to foster collaboration with and respect for The Ho-Chunk Nation, specifically in her creating Ho-Chunk Day, File ID 53841. I have become an agent for implementing UW-Madison student and Chancellor Blank's initiative for honoring the Ho-Chunk's presence on this land, creating Ho-Chunk Heritage cruises of Lake Mendota. I often recite the "Our Shared Future" land acknowledgment when beginning a cruise to introduce the sacred nature of the lake and the surrounding springs, effigy mounds and village sites. Although I present a broad repertoire of stories and points of interest for these lake cruises, I have found that the Ho-Chunk lore moves people more deeply than any other perspective of this area. And the District 11 constituents and citizens of this city deserve a voice that continues Ald. Martin's work honoring the indigenous presence in this region.

Finally, we have increasingly challenging budgets every year, no surprise in view of legislative mandates and restrictions. Against that background, I see the Madison Parks Foundation as a particularly important organization for funding one of the most vital resources that makes our city so extraordinary. I recently worked with the Foundation on a park enhancement project and was impressed by the efficiency of their operation and their vision for the future. I will work on developing approaches for empowering the Madison Parks Foundation.

I would present additional important initiatives BUT do not want to undermine the sincerity of the response that follows.

Statement on whether you plan to run for alder in the Spring 2023 Election:

Absolutely NOT! I will not stand for election to this office next Spring. I know you hear that from applicants who later find good reasons for changing their mind. And by my rejection of continued service by becoming an elected representative, I do not wish to invalidate such reasons others may develop when serving as an interim alderperson. However, there are no circumstances whatsoever in which I will continue in this office after April 18, 2023. I only offer to serve now as an INTERIM alderperson, providing continuity between elected representatives so that the citizens of the 11th District continue to be effectively represented until an election can be held when the citizens can ELECT their next alderperson, free of the imprimatur that accrues to an incumbent.

A resume covering the relevant parts of my neighborhood and civic experience, work history and education is attached.

I want the position for the following reasons:

Citizens should contribute to their community by participating in its activities, by attending at least some of its civic meetings when possible, and when appropriate serving as members on boards, etc. As you will see on my resume in a little more detail,

- at the city level, I have served on the Madison Arts Commission and the Madison Sister City Commission, I helped Make Music Madison get started, and I was instrumental in establishing the non-profit Friends of the Madison Arts Commission (FoMAC).

- at the neighborhood level, I served for many years on the board of directors of the Hill Farms Neighborhood Association (HFNA). For almost 20 years I coordinated the annual 4th of July neighborhood celebration, and initiated the neighborhood Halloween parade and pizza party. I am currently a member of the Hill Farms Planning Committee.

- at a community level (not included in the resume), since school boards around the state have been under assault, over the past few months I have attended Madison and Middleton School Board meetings to serve as a moderating voice if necessary.

The coming year would be a good time for me to take on a new responsibility. My wife and I are retired without regular employment, and although I currently attend many evening groups and events, those could all take a back seat for a year to Common Council responsibilities, leaving the one major commitment of caring for our two grandchildren most weekday afternoons.

I would hope to accomplish the following:

As a one-year lame-duck alder I would be in an unusual position. On the one hand, I could not expect to contribute as effectively as I might if I were a long-standing member of the council and its committees. I have read Alder Martin’s blog posts over the past five years, and I recently reviewed the more current ones, but I would still face a substantial learning curve simply to understand the issues as well as the personalities on the Common Council and in city government.

On the other hand, I would not be constrained by the prospect of re-election from voicing my honest position on any issue. One personal quality I might contribute to council and committee meetings would be my background as an Administrative Law Judge (ALJ), in which I developed

a strong habit of remaining in the middle on an issue as long as possible, listening to both sides and remaining uncommitted until all the evidence was in, before finally taking a position.

I would not plan to run for the seat in the spring 2023 election.

I would receive great satisfaction from serving my community as an alder, even for a little less than a year, but I have no further ambition and I do not plan to run in 2023. That being said, the ability to change one's mind is a mark of thoughtful intelligence, so I try never to take an inflexible position. Even with that remote *caveat*, it is difficult for me to imagine any circumstances that would make me want to run again.

My name is Bill Tishler, and I have been a resident of Madison for over 50 years, living in the Sunset Hills and Westmoreland neighborhoods. I respectfully submit my application for consideration to be Interim District 11 Alder.

When my wife, Jennifer, and I began looking for our first house in 2004, we wanted to live in an area that was affordable, within walking distance to public schools, parks and libraries, and had quick access to public transportation and a bike path. District 11 had all the amenities we wanted and were lucky to find a single story ranch house on Herrick Lane that we later learned was in the 1954 parade of homes. One of the first neighbors who came over to greet us was former Madison Mayor Otto Festge who lived two doors down from us. We still have the ferns he gave us growing in our backyard.

I have a strong interest in civic engagement that was instilled in me at an early age by my father William H. Tishler who is a retired professor of landscape architecture and an expert on historic preservation. My father was instrumental in the design of the Vilas Children's Zoo, served on the Madison Urban Planning Commission and nominated numerous Madison buildings and natural areas to the National Register of Historic Places. I had the opportunity to work closely with my father over the years on a documentary film and televised lecture course about landscape architecture and environmental conservation and was inspired by his teachings on the cultural landscape, sense of place, and historic preservation. The newest member to our family, our dog Violet, joined us in 2020. I am also fortunate to have extended family in the area including my parents who live a few miles away.

If appointed, my priority will be to represent District 11 constituents, including working closely with neighborhood associations since it is these groups that volunteer so much on their time and talent to improve the quality of life in our area. I will work hard to foster two-way communication with District 11 constituents and neighborhood associations by encouraging individuals to subscribe to the District 11 – Alder email list, attend neighborhood association meetings and convene regular conversations with the District 11 Alder at the Sequoia library and at local coffee shops in the area.
