WHEREAS, many of the public sewer mains are old and in poor condition, allowing infiltration of groundwater, and;

WHEREAS, the Madison Sewer Utility is aggressively replacing these sewer mains to lessen the problem of sewer flooding, and;

WHEREAS, it is prudent to replace the private sewer laterals in conjunction with the sewer main, when the street is being reconstructed, and;

WHEREAS, the property owner is reluctant to replace the lateral at his/her sole expense, and;

WHEREAS, it is reasonable for the Sewer Utility to participate in the cost to encourage property owners to replace their laterals in conjuction with street reconstruction projects.

NOW, THEREFORE, BE IT RESOLVED, that a policy is hereby established to share the cost of replacement of sanitary sewer laterals within the public right-of-way and the limits of street reconstruction projects, such that the Sewer Utility pay 75% of the replacement cost for the subsurface installation of the lateral, from the sewer main to the property line, and 50% of the surface restoration costs in accordance with standard City policy on street reconstruction projects.

BE IT FURTHER RESOLVED, that this policy is independent of and shall not supersede the City's Sanitary Lateral Sewer Service Restoration Policy to repair damaged laterals by City forces as authorized by Resolution No. 26,439, adopted May 28, 1974, and amended by Resolution No. 50,320, ID No. 13742, adopted September 7, 1993.

BE IT FURTHER RESOLVED, that Resolution No. 54,168, ID No. 21437 adopted May 6, 1997, is hereby rescinded.

>Cassie, I have the policy. It is brief, in the form of a one page
>resolution. I dont believe its on any active computer file so I will
>need to fax it to you. What #?
>A couple of items of note:
>When we first established this policy, we did a 75% City match to
>encourage the homeowner participation. This included restoration items
>like curb and sidewalk that we had to dig thru to relay the lateral.
>However, curb and sidewalk are shared at 50% on a street reconstruction
>assessment policy, so our new lateral policy was in conflict with our
>street reconstruction assessment policy. We decided to revise our
>policy for 75% on the lateral only and 50% on the street restoration
>items associated with the lateral.
 >The second thing we noted: When we first started this policy we sent
 >letters to anyone being assessed by a reconstruction policy, stating our
 >lateral policy and encouraging them to participate. It was voluntary
 >and they would need to indicate they wanted to participate. We did the
 >same verbally at all public hearings for the project. We found that
 >this approach gave only 10% to 20% participation.
 >The next year, I reversed this process and automatically included
 >everyone on the assessement, to recieve a new lateral. However, in the
 >letter and at the hearing, we stressed that it was voluntary and we
 >would remove the lateral assessment and lateral work if they requested
 >us to do so. We get about 5% requesting non participation. So as I had
 >suspected, the majority were apathetic to the issue and preferred to go
 >along with our proposal and not get involved.
 >Lastly, this still does not solve the lateral problem from the Street
 >property line to the house (30 feet in most cases). Some homeowners are
 >aware of this and coordinate replacement of that portion of the lateral
 >privately. Most of these homeowners are ones that have experienced
 >problems with their laterals. At least we know that as the remaining
 >laterals become problematic on the private property side, they will have
 >a good point of connection without needing to go into the street.
