## 1. Introduction

The Madison East-West Bus Rapid Transit (BRT) Project (the project) is a proposed 15-mile route serving eastwest travel needs in central Madison, Wisconsin. The project extends from East Springs Drive on the east side of Madison to a proposed new park-and-ride at Junction Road on the west side of Madison. Operating primarily via East Washington Avenue, University Avenue, and Mineral Point Road, the BRT line would serve the major regional destinations of the isthmus (downtown Madison), the University of Wisconsin-Madison (UW) campus, Madison Area Technical College, and major employers and several shopping centers located throughout the corridor. BRT buses would use a combination of center-running bus lanes, side bus lanes, and mixed-traffic lanes. The project also includes electric bus charging infrastructure at the Sun Prairie Park-and-Ride and the Metro Satellite Maintenance Facility where BRT layovers would occur.

This technical report provides results of the analysis of impacts to nearby community and social resources from the project. The report discusses the regulatory context for the analysis, methods used, and existing conditions within the study area. Potential operating (long-term) impacts and construction phase (short-term) impacts are evaluated, and potential mitigation measures to address these impacts are described.

The project would be constructed in a developed urban environment, in an area with high levels of existing bus service. The proposed Madison East-West BRT Project would complement existing transit service in the corridor to connect key activity centers such as Madison Area Technical College, Downtown Madison, the University of Wisconsin – Madison campus, the Wisconsin State Capitol and capitol complex buildings, and major employers located throughout the corridor, including CUNA Mutual, businesses in University Research Park, and several shopping centers.

The proposed project service is intended to help residents connect to community resources. Transit access to community resources would be improved by the enhanced transit service and facilities. New and updated facilities and service would improve the transit experience for users and communities along the corridor, and better connect people to shopping, employment, education, and recreational opportunities throughout the corridor.

The proposed project would construct new dedicated stations and guideways in areas that already experience heavy automobile, transit, bicycle, and pedestrian traffic. The majority of the proposed project would be constructed within existing right-of-way, see Chapter 12, Acquisitions and Relocations Required. Thus, it would not affect, separate, or isolate any neighborhoods or communities along the corridor, nor would it result in negative impacts to community resources based upon the analysis in this document.

# 2. Regulatory Context and Methodology

This technical report establishes a socio-economic profile of the corridor and identifies community facilities within one-half mile from the corridor and the Sun Prairie Park-and-Ride facility. The report will include descriptions of the impacts of the proposed project on the facilities. No specific laws or executive orders regulate how impacts to community facilities resulting from transit projects are evaluated. The National Environmental Policy Act (NEPA)<sup>1</sup> and the Wisconsin Environmental Policy Act (WEPA)<sup>2</sup> provide the general basis of considerations for discussing community and social impacts. Community facilities include schools, colleges, libraries, community centers, parks, medical facilities, places of worship, police and fire departments, and

community service organizations. If community facilities would be impacted by the project, the nature and extent of the effects are noted.

Potential operating (long-term) impacts and construction phase (short-term) impacts are evaluated, and potential mitigation measures to address these impacts are described. The facilities highlighted in this technical report also inform the Visual Quality, Noise Impacts, and Acquisitions and Relocations Required chapters of the documented categorical exclusion.

The community facilities are listed from west to east and by station area. Additionally, facilities located within 200 feet of the corridor are highlighted for proximity to potential impacts from construction.

# 3. Existing Conditions

The following section documents the existing socio-economic profile of the corridor and the community facilities within one-half mile of the corridor, such as schools, colleges, libraries, community centers, parks, medical facilities, places of worship, police and fire departments, and community service organizations. Each community facility is labeled with a number in Figure 3 through Figure 6, corresponding to the number in Table 4. That table also describes the purpose of the facility, lists the nearest station area or project element, and indicates whether the facility is within 200 feet of the corridor.

### 3.1. Socio-Economic Profile

There are approximately 97,700 individuals living within one-half mile of the proposed project. Based on the U.S. Census Bureau 2015-2019 American Community Survey, median household income in this area is \$54,531. This is lower than the median household income for either the City of Madison or the State of Wisconsin, shown in Table 2. Figure 1 shows the median household income by U.S. Census block group.

Of the total population in the study area, 30.2 percent are living with an income below the federal poverty level.<sup>3</sup> Figure 2 shows the percentage of the population living below the poverty level by U.S. Census block group.

Table 2 shows that compared to the City of Madison and the State of Wisconsin, the project area has a high percentage of housing units occupied by renters, a higher percentage of people with a bachelor's degree or higher, and a higher percentage of zero-vehicle households. The project area has a lower percentage of people experiencing disabilities and a lower percentage of seniors over the age of 64 than the City of Madison and the State of Wisconsin.

As of January 2021, the U.S. Bureau of Labor Statistics estimates the labor force in the Madison Metropolitan Area to be 379,574 persons, with an unemployment rate of 3.5 percent. This is lower than the unemployment rate of both the State of Wisconsin (4.5 percent) and the United States (6.3 percent).<sup>4</sup>







### 3.2. Community Facilities

NEPA and WEPA form the general basis of consideration of these potential social impacts. The community facilities impact analysis is based on the geographic location of facilities such as schools, colleges, libraries, community centers, parks, medical facilities, places of worship, police and fire departments, and community service organizations in relation to the corridor.

As a fully developed urban area, the proposed project area contains many community resources. The corridor is also lined with commercial nodes.

Table 3 identifies community resources within one-half mile of the proposed project, organized by station area or project element. The resource study area is the area within one-half mile of the proposed alignment. The one-half mile study area considers not only potential negative impacts project construction and operations could have on the facility, but also the improved access that the project would provide to community resources within a short walk of stations.

Table 4 lists 245 individual community resources with their address, general purpose, station area or project element, and whether the facility is within 200 feet of the corridor. The facility number corresponds with the maps in Figure 3 through Figure 6. The analysis highlighted community facilities within 200 feet of the proposed alignments for potential impacts from visual changes, noise impacts, right-of-way acquisitions, and impacts caused by construction, based on the results from the following chapters of the Documented Categorical Exclusion, if applicable:

- Chapter 9, Visual Quality
- Chapter 10, Noise
- Chapter 11, Acquisitions and Relocations Required

• Chapter 22, Impacts Caused by Construction

Table 5 lists the 66 parks and recreation areas from west to east within the study area and highlights parks within 200 feet of the corridor. The impacts to these facilities are discussed in Chapter 16, Use of Public Parkland and Recreation Areas.

Table 6 lists 57 neighborhood, homeowner, and condominium associations alphabetically within the study area, with their map number corresponding to the numbers shown on the map in


### Figure 7.






Figure 4: Community Resources – Central Station Area








Figure 6: Community Resources – Sun Prairie Park-and-Ride and Metro Satellite Maintenance Facility





# 4. Environmental Consequences

### 4.1. No Build Alternative

Under the No Build Alternative, construction and operation of the Madison East-West BRT Project would not occur, and related impacts to community facilities would not be observed. Community resources throughout the study area would reflect existing conditions.

### 4.2. Build Alternative

Under the Build Alternative, the Madison East-West BRT Project would be constructed, and changes would occur during the construction and operation of the project.

### 4.2.1. Operating Phase Impacts

During the operating phase, change would result from the presence of new BRT infrastructure and buses, with most change occurring proximate to the dedicated guideway and stations.

#### **Visual Changes**

Several views with high visual quality were identified along the corridor, including historic sites/districts and parks. Potential medium contrast visual impacts were found at the Junction Road Park-and-Ride with construction of a new park and ride lot on undeveloped land. These visual impacts are not expected to adversely affect community facilities within 200 feet of the corridor. The visual impacts are discussed further in Chapter 9, Visual Quality.

#### **Noise Impacts**

No long-term noise impacts were identified for the project. Therefore, no long-term noise impacts to community facilities within 200 feet of the corridor would occur. The noise impacts are discussed further in Chapter 10, Noise.

#### **Right-of-Way Impacts**

Right-of-way impacts were found for the community facilities listed in Table 7 and are discussed further in Appendix H: Acquisitions Technical Report. Minimal permanent right-of-way and temporary easement impacts to six community facilities include slivers of land directly adjacent the current right-of-way, but these are not expected to adversely affect these community facilities. "Facility Number on Map" refers to the maps in Figure 3 through Figure 6. Potential impacts to parks are discussed in Appendix L: Parkland Technical Report.

#### **Access to Community Facilities**

Local service along the East-West BRT route would be reduced when the project begins operating. Residents would have to walk farther to access transit service because BRT would make fewer stops than local service did and because the East-West BRT route is more direct than local routes, reducing the geographic coverage of transit service. However, people in these neighborhoods would be able to access more destinations in less time via transit because the service is faster, more frequent, and more reliable; thus, access to community facilities would not be impacted by implementation of the project.

#### 4.2.2. Construction Phase Impacts

There are 31 community facilities within 200 feet of the corridor with primary access along Junction Road, Mineral Point Road, Whitney Way, Sheboygan Avenue, Segoe Road, University Avenue, Campus Drive, Johnson Street, State Street, Capitol Square, East Washington Avenue, Wright Street, Anderson Street, and Mendota Street. These facilities may experience temporary construction impacts for up to one construction season, which would last for six to eight months.

Although temporary in nature, construction phase impacts may affect community facilities and neighborhood cohesion. Detours may increase traffic through residential neighborhoods or change access to community facilities, and parking closures may change access to these facilities as well. Similarly, sidewalk closures and detours may affect pedestrian traffic patterns. Construction impacts such as increased levels of noise and dust may temporarily affect neighborhood character, primarily in areas that are relatively quiet. The presence of large construction equipment may be perceived as visually disruptive, resulting in temporary effects to community character, particularly in residential settings. Construction phase impacts are discussed in greater detail in Chapter 22, Impacts Caused by Construction.

#### 4.2.3. Impacts Beyond 200 Feet but Within One-Half Mile of the Proposed Alignment

Consideration of visual, noise, right-of-way, and construction impacts determined that the East-West BRT Project would not have impacts to community facilities beyond 200 feet but within one-half mile of the corridor based on their distance from the proposed alignment. Rather, the project improves access to community facilities and destinations throughout the corridor by creating a reliable, fast, and frequent transit connection.

In addition, the project proposes to reconstruct the existing sidewalk facility along Mineral Point Road as a shared-use path; an improvement that would help foster an all ages and all abilities bike network in the city. This connection would improve multimodal access to community facilities along Mineral Point Road.

# 5. Mitigation Measures

The City of Madison does not anticipate adverse impacts to community facilities along the corridor, therefore, does not propose additional avoidance, minimization, or mitigation measures for the corridor.
