- MGO 33.01(12)
 - WIC's position: We do not want to be recorded because topics we discuss are sensitive. By recording, we do not believe it supports an inclusive, safe space to speak freely when a meeting is recorded, and could be subject to impacting employees growth at the City. We also feel like we were left out in the process to create the ordinance.
 - WIC spoke with City Attorney. CA said ordinance states currently WIC has to record meetings. WIC attempted to meet with District 19 Alder Furman to discuss an amendment to this ordinance that would exempt WIC and MAC from the recording rule. WIC has not been able to get in contact with Alder Furman to discuss further.
- Inclusive Workplace Implementation Update
 - Anne Nowak and Kym Woodley presented.
