2. Treasurer's Report

- b. Start a cash balance of 15-20% of annual revenues
- c. Increase both the MUFN Overhead Recovery and MUFN Circuit/Fiber Use Fees to \$200 and decrease the MUFN Ring completion circuit fee to \$0.

The Budget Subcommittee will revise the budget to consider the proposals discussed and present it at the next MUFN meeting.

3. GLS Utility Locate Contract Renewal

A motion by Christian, seconded by Knutsen, to have the Chair, Sarah Edgerton, sign the 3 year contract with GLS Utility.

4. CTC Fiber Audit Information

The City of Madison has signed a contract with CTC for a Fiber Audit. Herb will reach out to select members to join the kick-off call with CTC for the Fiber Audit. An Outline for the next 7 years will need to be drafted.
