Discussion item 1: WINMetro, City of Madison, MUFN Project: 222 to UW Doit to Shorewood Hills to Segoe Rd Fiber Build Summary

MUFN Operations Committee - Dan Parenteau 8/16/2018

Segments:

- 1) Replace damaged 96ct along University Ave with 288ct cable.
- 2) Install new 288ct cable from UW Doit to 222 W Wash.
- 3) Replace remainder 96ct along University Ave with 288ct up to Segoe.
- 4) Re-route existing City 432ct spur out of CCB from Bedford area to 222. (this segment is out of the financial scope of the project)

Usage: WIN and City/MUFN split the 288ct cable 50/50 with each entity having ownership of 144 strands. **Costs:** Cost split for construction (not including splicing) was based on an original estimate of \$125,000 project cost split \$85,000 WIN, \$20,000 City IT, and \$20,000 MUFN. Proposal is that those ratios (68/16/16) carry forward as costs are finalized.

Responsibilites: City of Madison TE responsible for operating cable and conduit. In addition, TE will shepherd the construction permitting and traffic control. WIN, City IT and MUFN will contribute with project management, coordination and financially.

What this does:

- Additional strands from 222 to UW Doit. This will function as an express path for the Johnson St 144ct path
- Additional strands and hopefully a more freeze resistant cable (microduct) from UW Doit west down University.
- Additional strands from 222 to CCB, a major cable cross-connect thoroughfare which is currently full.
- Replacing the damaged CoM fiber cable in Campus Drive without new conduit construction

What this does not do:

- Doesn't guarantee we won't have freeze issues next winter.
- Doesn't provide a complete alternate path for the UW Dayton St Steam Tunnel construction project relocate.
- Doesn't fund necessary splicing.

Update: TE discussed starting this work May 2019 at the 3/14/2019 operations meeting.



Discussion item 2: Dane County Fiber build with DOT

New 144ct DOT cable. DaneCo to get 72 strands to be managed by MUFN. Splice cost during a repair/relocate could be split (tbd)

- New DaneCo conduit & cable. MUFN managed. Could be located by TE under paid contract with Dane County or MUFN (tbd)
