given pursuant to sec. 19.85(2), Wis. Stats., that it may reconvene in open session without waiting 12 hours as specified in the statute.

Ankita Bharadwaj moved to go into closed session, seconded by Maia Pearson. Motion approved unanimously.

4. Independent Monitor Recruitment: Review of Supplemental Questions
