## Earned Income Tax Credits

EITCs help families and individuals who earn low-to-moderate incomes keep more of what they earn. They lower taxes, add to wages and make work more affordable. An Earned Income Tax Credit can result in thousands of extra dollars to families- yet every year, many families who think they're not eligible fail to claim them.

If you have earned income but don't think you need to file, it may be beneficial to file to see if you qualify for the credit.

## Very Important - Save Time

Please bring **ALL** of the needed items with you to the site. If items are missing, your tax return **CANNOT** be completed

- ◇ **Picture ID (mandatory)**
- ◇ **Copies of actual social security cards for you, all dependents, and spouse if filing jointly (mandatory)**
- ◇ Wage statements – Form(s) W-2
- ◇ Pension and Social Security Statements - Form(s) 1099R and SSA-1099
- ◇ All 2015 informational statements, including:
  - Interest and dividends statements— Form(s) 1099INT and 1099DIV
  - Mortgage interest statements— Form(s) 1098
  - Tuition payments statements— Form(s) 1098-T
  - ACA Marketplace statement-form 1095A
- ◇ Copy of last year's tax return, if available
- ◇ Information about any other sources of income, both taxable and non-taxable
- ◇ Info on all other deductions/credits (include charitable contributions or employee business expenses)
- ◇ If homestead credit is claimed:
  - A completed rent certificate and/or copy of your 2015 property tax bill
  - A printout of any Wisconsin Works (W2) payments received in 2015
- ◇ A record of any estimated tax payments made for the 2015 tax year
- ◇ If direct deposit of your refund is desired, a voided check for a checking account or a deposit slip for a savings account
